It is however of the utmost importance as when people understand that they are dying, their preferences for treatment and care commonly change. Similarly, clinicians are likely to make different decisions for those with short expected survival compared to those with many years of life ahead of them. Hence, the identification of those at high risk of dying is necessary to ensure individualised care, efficient use of health resources and meaningful outcomes at the end of life. It is an area requiring innovative, patient focused and cross boundary cooperation.
